UK Delivery

Mainland UK delivery is free.

We aim to dispatch your order using a reliable, tracked delivery service. Once your order has been dispatched, you will receive delivery information where tracking is available.

For deliveries to areas outside mainland UK, including the Scottish Highlands and Islands, Northern Ireland, Isle of Man and Channel Islands, additional delivery charges may apply. These will be shown at checkout where applicable.

Duties & Import Taxes

Where possible, we will arrange **delivery with duties and import taxes paid (DDP)**, meaning you will not be required to pay additional customs duties or import taxes when your order arrives.

However, DDP delivery is not available to every destination. Where we are unable to offer duties-paid delivery, your order will be sent **with duties and import taxes unpaid (DDU/DAP)**. In these circumstances, you, as the customer, will be responsible for any customs duties, import taxes, handling fees or other charges imposed by your country when the parcel arrives.

Any such charges are outside our control and vary depending on the destination country's regulations, the value of your order and the goods being imported.

We recommend checking your local customs and import requirements before placing an international order if you are unsure whether additional charges may apply.

Delivery Times

International delivery times vary depending on your destination and the shipping service selected. Please note that customs processing can sometimes cause delays that are outside our control.

Delivery estimates do not include the time required to make your handmade shoes or boots. Please refer to the individual product page for the estimated production time before placing your order.

Customs & Import Charges

For international orders, customers are responsible for ensuring that the products they order can be legally imported into their country.
